## **SELECTION POLICY**

### **1. POLICY PURPOSE**

- 1.1. This Selection Policy outlines the process for selecting the respective teams to represent Great Britain at the 2022 World Junior Championships and 2022 European Junior Championships.

### **2. PERFORMANCE OBJECTIVE**

- 2.1. The target for these events is to provide a positive competitive opportunity in the long-term development of British junior swimmers towards future senior international success, whilst at the same time optimising the medal outcomes in Olympic individual and Olympic relay events.

### **3. SELECTION EVENT**

- 3.1. Selections will be made from performances at the 2022 British Swimming Championships, (Ponds Forge International Sports Centre), 5<sup>th</sup> – 10<sup>th</sup> April 2022 (“the British Championships”), subject to clause 6.2 below.
- 3.2. In the event that the 2022 British Swimming Championships is cancelled, a revised selection policy will be published.

### **4. TEAM SIZE**

- 4.1. Up to a maximum of 50 swimmers may be selected in total, subject to available funding, for the 2022 World Junior Championships and 2022 European Junior Championships. The total number of swimmers selected will be at the complete discretion of the Head of Elite Development. There is no obligation to use all places.
- 4.2. The split of places across both events (by number and gender) will be at the complete discretion of the Head of Elite Development.
- 4.3. Swimmers will normally only be selected for one of the respective teams. However, at the complete discretion of the Head of Elite Development, an athlete may, at any time, be invited to compete at both events.
- 4.4. Swimmers based overseas (outside of the United Kingdom) should take specific note of the General Conditions of this policy, with specific reference to clauses G3, G7 and G8.

### **5. AGE ELIGIBILITY**

- 5.1. Boys born 2004/2005/2006/2007
- 5.2. Girls born 2005/2006/2007/2008

### **6. INDIVIDUAL EVENT SELECTION**

- 6.1. Swimmers recording a time that equals or betters the Minimum Consideration Times set out in Table 1 in any round at the 2022 British Championships will be **considered** for selection. The achievement of a Minimum Consideration Time does not mean the swimmer has achieved automatic selection and does not guarantee selection.
- 6.2. Additional places (‘discretionary selections’) up to the stated maximum team size in 4.1 may be selected at the complete discretion of the Head of Elite Development. These discretionary selections can be made from swimmers who have not have achieved the Minimum Consideration Times listed in Table 1 at the British Championships but are deemed to be able to contribute to the Performance Objective set out in Clause 2.1. The Head of Elite Development is under no obligation to use these discretionary places.

## **SELECTION POLICY**

- 6.3. The Head of Elite Development will not normally select any athlete for either event if the athlete has been selected for the 2022 World Championships (senior) Team, but the Head of Elite Development retains complete discretion to make such selections.

### **7. RELAY EVENT SELECTIONS**

- 7.1. All team members selected under clauses 6.1 and 6.2 for individual events will be considered to be eligible for relay team selection.
- 7.2. Additional swimmers may be selected for the relay events at the complete discretion of the Head of Elite Development under clause 6.2.

### **8. EVENT ENTRIES**

- 8.1 This policy only selects the swimmers onto the 2022 World Junior Championships or 2022 European Junior Championships Team. The Head of Elite Development and respective Head Coaches for the two events have the responsibility to then determine individual event entries, including those for non-Olympic events.

### **9. ASSEMBLY**

- 9.1 All selected swimmers (for both events) will be expected to cover their own expenses to the designated assembly point in the UK to depart for the event.

### **10. ANNOUNCEMENT**

- 10.1. The 2022 World Junior Championships and 2022 European Junior Championships Teams will be announced on Friday 27<sup>th</sup> April 2022, subject to clause 4.3.

## **SELECTION POLICY**

### **SELECTION POLICY GENERAL CONDITIONS**

#### **Eligibility**

Athletes must:

- G1 Be a British citizen and eligible to represent Great Britain as per the FINA General Rule 2 (GR 2).
- G2 Have completed a Selection Acceptance Form to confirm they will be available to participate. Failure to do so will be interpreted as non-availability by British Swimming. Selection Acceptance Forms will be provided by British Swimming to qualifying team members.
- G3 Be available to fulfil all team commitments.
- G4 Comply with any other FINA eligibility criteria from time to time, including in respect of nationality and/or anti-doping.

#### **Team Commitments**

All Team members will be required to:

- G5 Comply with the British Swimming Code of Conduct. A breach of the British Swimming Code of Conduct may result in de-selection from the team.
- G6 Abide by media protocols of the British Swimming Programme. Athletes must only speak to the media about their own performances and group coaches must only comment on performances of swimmers in their group. The event Head Coach and Head of Elite Development may discuss performances of the entire team.
- G7 Not take holiday or attend overseas camps and/or competitions between the British Championships and the meet for which they have been selected without prior written approval from the Head of Elite Development.
- G8 Make themselves available for all team activities designated by the Head of Elite Development (including but not limited to preparation camps and staging camps). No team member will be allowed to leave a national team camp or undertake any activities that are not directly relevant to the team camp programme, this includes any external media, sponsor or social activities. Failure to attend the required activities could result in withdrawal from the team. Under exceptional circumstances, written approval to be excluded from activities may be given by the Head of Elite Development.
- G9 Comply with British Swimming and FINA swimwear regulations while competing at the 2022 European Junior Championships and 2022 World Junior Championships.

#### **Withdrawals**

- G10 If for any reason an athlete is unable or unwilling to fully comply with the Team Commitments (G5 to G9) they may be withdrawn from the team.
- G11 Swimmers becoming unfit due to illness or injury (physical or mental) at any time following their selection must notify British Swimming immediately and will be required to undertake a full medical examination which may result in the swimmer being de-selected from the team at the complete discretion of the Head of Elite Development. In the event of injury or illness athletes may be deselected if they pose a risk to themselves, other athletes or team staff as determined by the British Swimming Chief Medical Officer or his designate.

## **SELECTION POLICY**

### **Replacements**

G12 Replacement of athletes withdrawn from the team will be considered at the complete discretion of the Head of Elite Development if viewed to be in the best interest of the overall team performance, subject to clause 4.1.

### **Other**

G13 The World Class Programme Performance Leadership Group (PLG) may amend selection policies at any time at its discretion.

### **Appeals**

G14 Any appeals against selections in relation to selection policies must be made in accordance with the British Swimming Team Selection Appeals Procedures, available online at <https://www.britishswimming.org/performance/swimming/selection-policies/team-selection-appeals/> or by request from Adam Clarke, Head of Performance Services via email at [adam.clarke@swimming.org](mailto:adam.clarke@swimming.org). Athletes should be aware of the time limits contained in the Procedures, which are designed with the intention of resolving issues expeditiously and fairly.
